What is this course about?

This course discusses topics of the economics of cities and regions with an eye to providing a foundation for original empirical research in the area.

Grading

There are several course requirements. First, there will be homework, which can take the form of either referee reports (i.e. short writing exercises based on readings on the syllabus or on other mutually agreed upon papers) or problem sets. Second, there will be a class presentation. Finally, there is also a 5 page paper proposal. You can choose one of two grading schemes:

- Participation, 20%; Homework (4 assignments) 60%. Class Presentation of a recent article in the literature 20%.
- Participation, 20%; Homework (2 assignments) 30%. Class Presentation of a recent article in the literature 20%. Paper proposal (and brief presentation in class of the proposal) 30%.

Students may work on homework assignments and class presentation in pairs.

The second scheme is intended for PhD students and MA planning to apply to the Phd program who wish to do some research on issues related to the economics of cities and regions, the first for other students.
