## Course Information and Content

#### **LECTURE MODULES**

For both sections, LEC0101 and LEC9101, content will be organized by weekly asynchronous Modules on Quercus. You go to the course Quercus website and click on the Module which is identified by week. Each week we will cover that week's Module of pre-recorded lecture and tutorial videos, power point slides, cases, articles and quizzes. Each module is asynchronous online. LEC0101 and LEC9101 will not meet at a given lecture time, instead content will be posted by each Monday of the week for both sections. For each module, you are expected to complete the text readings, watch the pre-recorded videos, and complete the quizzes by the quiz due dates.

#### **LECTURES**

For both sections, LEC0101 and LEC9101, the lectures are asynchronous. Students will be responsible for all the material presented online, except the cases and articles referred to in the recorded lectures. The cases and articles are optional reading but could be used to inspire the questions you post on Pack Back. Students should be advised that much of the material covered at the lectures will be additional to the required readings and the power point slides. All of the lecture material, slides and the text are eligible for inclusion in the midterm test and final assessment.

#### **TUTORIALS**

For both sections, LEC0101 and LEC9101, students will be responsible for the posted tutorial questions, tutorial solutions and the pre-recorded tutorials. This material is eligible for inclusion in the midterm test and final assessment. Synchronous tutorials will occur each Wednesday, 1:10PM to 3PM, in the course room at Bb collaborate on the course Quercus site, starting Wednesday, January 21, 2021. Attendance at these synchronous tutorials is optional.

## **QUIZZES**

For both sections, LEC0101 and LEC9101, there will not be a quiz for the first module. The first quiz with Module 2 will be a practice quiz. There will be a quiz with each weekly module starting with Module 3 for the remainder of the course for a total of 10 quizzes worth 10 points per quiz. The quiz questions will be multiple choice questions based on the pre-recorded lecture and tutorial material, slides and the text readings in the weekly module. Each quiz is available for two (2) weeks after the Monday it is posted with its module. Once started, the student will have one attempt to complete the quiz in 30 minutes. Only the top 9 quizzes will be counted towards the final quiz mark for a total of 90 points. This will be converted to a grade of 100, worth 20% of the final mark. The quizzes can be accessed by the Quiz link on the course Quercus site.

#### **PACK BACK**

The course material in each module will generate questions with which each student with his or her diverse opinions and perspectives will ask. Each week, starting with Module 2, each student will post a curiosity question based on the course material in any of the modules, current or previous, on the course Pack Back site and post two (2) responses to two (2) questions selected among the questions posted by classmates.

In order to receive full credit each week, the student will post:

- 1. One (1) critical thinking focused question with a curiosity score of at least 60.
- 2. Two (2) responses with a curiosity score of at least 60.

Half credit will be awarded for a question and responses with a curiosity score of less than 60.

Each student will need to purchase an account with Pack Back to participate in this. This part of the course is worth 10% of the final mark. For Pack Back related questions, the student can contact <a href="mailto:help@packback.co">help@packback.co</a>

#### MIDTERM TEST

For both sections, LEC0101 and LEC9101, The Midterm Test will be administered synchronously from 11AM - 1PM and 7PM - 9PM, Monday, February 22, 2021 by Crowd Mark. All students will be assumed to be in the 11AM – 1PM session, unless they email me before the test to specify their wish to write in the 7PM - 9PM session.

#### **ASSIGNMENT**

For both sections, LEC0101 and LEC9101, an Assignment will be available Monday, February 22, 2021 through Quercus and due Friday, April 9, 2021. Students will prepare an assignment of 6 pages on a course topic, approved by me. The topic will be the economic analysis of a law, rule, legal problem or legal case the student chooses and will be worth 15%. More detailed instructions will be posted in a separate document after the Assignment starts on Monday, February 22, 2021 and it will be due on Friday, April 9, 2021, the last day of classes.

#### FINAL ASSESSMENT

The Final Assessment will be administered during the Examination period, April 13, 2021 to April 23, 2021 on Crowd Mark. The Faculty of Arts and Science will set the exact date and time later in the term, which will then be announced on Quercus.

# Course Objectives and Learning Outcomes

<u>For both sections</u>, LEC0101 and LEC9101, this course involves the practical application of microeconomic theory to common legal problems: torts, contracts, property and crime, and the limitations of economic analysis. No previous familiarity with the law is assumed. (This is an economic analysis of legal issues, not a course in law).

## Late Submissions

Policy regarding late submissions.

<u>For both sections</u>, LEC0101 and LEC9101, <u>the Make-Up Test will be administered from 11AM - 1PM, Monday, April 12, 2021 on Crowd Mark</u>. Only one make-up test will be scheduled for this course. This test will cover all the lectures, readings and slides for the course period up to and including Lecture 10. The Make-Up Test is worth 25%.

## Regrade Request

A student who believes that their written term work has been unfairly marked may ask the instructor for re-evaluation. Students have up to one month from the date of return of an item of term work to inquire about the mark. Such re-marking may involve the entire piece of work and may raise or lower the mark.

Any appeal of the mark beyond the instructor in the course may only be made for

term work worth at least 20% of the course mark. Such appeals must be made in writing to the department within one month after the work was returned, explaining in detail why the student believes that the mark is inappropriate. The appeal must summarize all previous communications between the student and previous markers of the work. The student must submit the original marked piece of work.

If the department believes that re-marking is justified, the department will select an independent reader. The student must agree in writing to be bound by the results of the re-reading process or abandon the appeal.

Where possible, the independent reader should be given a clean, anonymous copy of the work. Without knowing the original assigned mark, the reader will

determine a mark for the work. The marking of the work should be considered within the context of the course of instruction for which it was submitted. If the new mark differs substantially from the original mark, the department will determine a final mark taking into account both available marks.

internet connection. A phone cannot be an acceptable substitute as some required components may not be accessible on smartphones. A camera and mic are required for online contact activities such as office hours. High speed broadband access (LAN, Cable or DSL) is highly recommended

This course requires the use of computers, and of course, sometimes things can go wrong when using them. You are responsible for ensuring that you maintain regular backup copies of your files, use antivirus software (if using your own computer), and schedule enough time when completing an assignment to allow for delays due to technical difficulties. Computer viruses, crashed hard drives, broken printers, lost or corrupted files, incompatible file formats, faulty internet, and similar mishaps are common issues when using technology, and cannot be an acceptable ground for a deadline extension.

## Assignment and Turnitin.com

You will need to be proactive to avoid technical and other difficulties—which put strains on your internet bandwidth, learning how to scan efficiently, carefully reading all assessment instructions, and contacting your instructors/TAs immediately with any problems.

You need to store your work for this course in at least two places: your hard drive plus a memory card or the cloud. Make multiple backups of your files and physically store the backups in a different location from your originals or online. Remember: all hard disks will fail. Indirectly, this course measures your ability to manage computer files. Computer or file failure does not excuse you submitting your work.

You will need the hardware, software, and knowledge to scan your handwritten work to be uploaded. You must be able to scan efficiently without creating very large files: you may need to learn about your phone or scanner, install software/updates, and/or search for solutions online. Most phones can scan (making a separate scanner unnecessary) and we accept PDF, JPG, and PNG files.

Normally, students will be required to submit their course essays to Turnitin.com for a review of textual similarity and detection of possible plagiarism. In doing so, students will allow their essays to be included as source

documents in the Turnitin.com reference database, where they will be used solely for the purpose of detecting plagiarism. The terms that apply to the University's use of the Turnitin.com service are described on the Turnitin.com web site.

- · requiring that you include the call numbers or web site addresses of all sources cited in your paper.
